



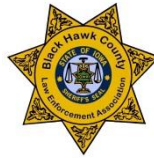

1st Annual Law Enforcement Tactical Pistol Competition

Saturday, June 17th, 2017 @ 0900 hrs.





The competition will consist of five stages with 250 rounds of ammunition. All officers competing must use their duty weapon along with duty holster (no competition pistols allowed). Participants are responsible for bringing their own ammunition, eye and ear protection and body armor. The cost of the event will be \$40.00 per competitor, with lunch provided for competitors. Additional lunches are available for spectators at \$5.00 per meal.

The competition is open to the first 150 competitors who register. If you don't get registered within the first 150 competitors, your entry fee will be refunded. Deadline for the competition will be **June 1st, 2017**.

Shoot House: Live fire shoot house course (50 rounds). Tactical entry and room clearance.



50 Yard Pistol Range:

- FBI Bullseye Course (30 rounds slow fire, max 25 yards)
- CSAT Pistol Course (25 rounds, max 25 yards)



100 Yard Rifle Range: (45-60 rounds)

- Combat/Stress Course with multiple target engagement



Dueling Tree:

- In the event of a tie, or perhaps a separate event.



The Raymond Range Training Facility was founded in 2010. It is now the primary training location for several law enforcement agencies in Northeast Iowa, including the Black Hawk County Sheriff's Office. The facility boasts firearms ranges at 25, 50, 100, and 300 yards. With multiple classrooms, high speed internet, a 3,600 sq ft live-fire shoot house, the RRTF is one of most comprehensive law enforcement training facilities in the Midwest.

The entire facility was recently expanded to encompass nearly 100 acres of training ground, including an 18 acre lake. It boasts terrain for woodland, open field, urban, and waterborne operations.
