


#### **Calls For Service**

In 2007, the Black Hawk County Sheriff's Office responded to 9,405 calls for service from the 133,133 calls our dispatch center fielded for all of Black Hawk County.

This year the dispatch center fielded 133,771 and our office responded to 11,945 calls, accounting for an increase of 2,540 more calls for service in the last year.



#### Frequency of Calls by Month





#### **Calls Resulting in Arrest (2008 Arrests)**







#### It's Been A Busy Year!

The Patrol Division placed an acute focus on traffic safety and OWI related offenses in the year 2008. As a result, our OWI arrests are up and our enforcement efforts continue to receive attention from the Governor's Traffic Safety Bureau.

We partner with the GTSB for equipment and overtime funds to allow us to continue placing a spotlight on the importance of alcohol enforcement and detection

We continue to see the demands of the crime in Black Hawk County task the Patrol Division, and each time the deputies of this division step up and continue to have positive impacting results.

#### Drug Busts Are Up

The past year marks another attempt (spurred by the patrol division) to spotlight narcotic violations, and with this focus, patrol deputies have increased drug related arrests. With this focus, more federal cases are being worked and investigations and arrests continue.

We recognize that a majority of all crime that is committed in Black Hawk County is directly or indirectly related to illegal drugs in our communities, so it is our effort and focus to continue to place an emphasis on detecting and deterring this crime in our county.

### **Civil Division**

#### Civil Posts Another Great Year

In 2008, the division processed a grand total of **20,066** court processes. This year the division served 1,381 more papers than one year ago, resulting in fewer papers returned unserved.

These processes include Writs, Condemnations, Liens, Levies, Garnishments, Subpoenas, etc.

The civil process is one of only two, Iowa Code mandated services for the Office of the Sheriff.

He (the Sheriff) must maintain a jail and must support the courts and civil procedure in his county.

In carrying out these duties in 2008, the Civil Division posted one of its highest totals in recent years.

### Overview of the Civil Division

In compliance with the Iowa Code, and the Iowa Rules of Civil Procedure, the Civil Division of the Black Hawk County Sheriff's Office is responsible for the execution of all writs and other legal processes issued to the Sheriff by legal authority.

Deputies working in the Civil Division are commanded by a Captain and supported

by one Sergeant. Civil Deputies are trained extensively in the proper execution and service of processes. The Sheriff's Office is responsible to the courts and acts as an officer of the court for the service of these actions. There is also a very close working relationship with the Black Hawk County Attorney's Office. Deputies serve subpoenas to witnesses summoned for criminal proceedings, as well as helping the Attorney's Office with fine collections. The Civil Division is a statutory responsibility unique to the Sheriffs in the State of Iowa.

### **Investigations Division**

In all this division continues to be aggressive in solving and producing arrests on investigative cases, still able to boast one of the state's highest "cases solved" rates. And, as always service and responsiveness remains our focus.

### Thefts, Drugs and Vandalisms Up in 2008

The Investigations Division had its hands full this year, seeing an increase in thefts and criminal mischief crime. Our detectives have also been busy solving several burglaries, although we witnessed a third year of reductions in this offense.

We are quite prideful of our detection, deterrence and prevention of criminal offenses and take it quite personally when an offense occurs. This personal involvement in the investigation has lead to one of the highest "case closed" ratings in the entire Midwest.

Although burglaries were down slightly this past year, they continued to be a large part of any discussion during the past year. As Narcotic violations continued to increase in focus, more burglaries were detected and many cases have carried over into 2009 as the investigations continue.

Theft from Motor Vehicles and Assaults rounded out the plate of offenses that took precedence for the last year.
