without jeopardizing the basic tenants that this office has built our respected foundation from.




In 2010, the Sheriff's Office responded to 2,602 more calls for service than in 2008.

That constitutes just over an additional 7 calls for service every day.



In 2009, the Black Hawk County Sheriff's Office arrested 3,834 persons on criminal charges.
In 2010, this effort increased to 4,449 arrests.
This is just shy of 2 more arrests each day of the year.





The Sheriff's Office has focused much effort in 2010 on deterring illegal narcotics and alcohol related offenses. This year the Sheriff's Office worked 51 more illegal drug related incidents and increased its alcohol enforcement by 36%:

# Illegal Narcotics and OWI Arrests

The goal for 2010 was simple... increase productivity.

The results from the effort is now apparent in our 2010 statistics, and its exactly what the Patrol and Investigations staff expected.

Narcotics cases jumped sharply for a second year in a row from 319 in 2009 to 370 this year. OWI's also had a dramatic increase from 226 in 2009 to 273 in 2010.

The increased efforts have continued to improve the safety on our streets and in our communities.

## DRE is the 2010 Deputy of the Year

Deputy Dave Hinz was recognized in December as the 2010 Deputy of the Year. Deputy Hinz, a 3rd shift patrol deputy was cited for the award for continually performing his duties with professionalism, dedication and inventiveness. He was recognized further for his activities as a DRE (Drug Recognition Expert) and the additional personal time invested in making this effort a success.

According to Sheriff Thompson, "In 2010, Deputy Hinz conducted an additional 20 DRE examinations which resulted in 19 additional drunk or drug impaired drivers being removed from our county roadways. Through his individual efforts as a senior patrol deputy, he continues to make Black Hawk County a safer place to live and work."



# Investigators Continue to Increase Impact

As is evident in the chart below, much of the success that the Sheriff's Office enjoys is based on the aggressive deployment of a small group of savvy, ingenious, and dedicated investigators.

This group is able to pick up an initial investigation and find resolution that results in property recovery, arrests and satisfied victims and we are truly blessed to have the group of professionals that currently operate in the function of our Investigative Services.



## 2010 Harley Davidson's Added

For several years, the Sheriff's Office used motorcycle units for parades and patrol work, taking advantage of a minimal lease program. When that program went away, so did the motorcycles.

In 2010, the Sheriff elected to use money forfeited in drug cases to re-lease motorcycles for use in patrol, community services, and civil process services.

The use of a Harley Davidson motorcycle in lieu of a squad car saves gas, provides better community visibility and increases traffic enforcement capabilities in our contracted communities.





# Shadow Boxers Experience Success

Since October of 2009, the Shadow Boxers Youth Diversion Program has established growth potential and positive community impact for youthful offenders and "at risk" youth in Black Hawk County.

Fashioned after the inmate worker program, youths contract for one year to participate in community service and programming to affect a more positive approach to life and their obligations at school and home.

Shadow Boxers started with 13 families and has now grown to over 70 participating members.



# 2010 Community Services

**DON'T** Turns 10!!!

For 10 years now Drugs Offer No Tomorrow (DON'T) has been the Sheriff's Office answer to drug education in our rural community school districts.

The Sheriff's Office provides drug education to Dunkerton Community Schools, Union Community Schools, and Gilbertville Don Bosco School District.

Students learn to live a drug free life while working closely with our Community Services Coordinator, Deputy Joe Stafford.



We Serve Community Needs

Whether jumping into a cold pond on a December morning to raise money for the lowa Special Olympics, or getting hit with water balloons during Quakerdale's Mobile Summer Camp, Sheriff's Deputies work in our communities in unique ways not commonly associated with law enforcement. Always working to improve on our community partnerships, we can enjoy having a good laugh for a good cause, even if its at our expense.

### 24/7/365 Jail Medical Services

Beginning July of 2010, the jail began enjoying the services of 24 hour a day medical services. These services include emergency medical response to inmate issues, intake assessments of arrestees, routine treatment, mental health assessment and treatment, medication passes and improved response to and continuity of inmate medical care.

#### **Jail Room and Board Revenues:**

In the past two years, the Sheriff's Office has increased recovery of money owed to tax payers for the real expense of housing inmates by over \$100,000.

# Jail Services Division

# An Overwhelming Year of Highs

In the Jail Services Division, any effort of increased enforcement on the streets results in an increase in demands in the jail.

This year was no different. The Jail bore the weight of increased enforcement by the Waterloo Police, Cedar Falls Police and the Black Hawk County Sheriff.

Our facility can house 272 inmates on the housing level. Our average daily population rose to 267 this year, illustrating a nearly full to capacity jail for the year.

# In 2010, the Jail Medical Clinic provided:

- 4,643 Inmate medical visits
- 2,320 Inmate Mental Health visits
- 1,882 Mental Health prescriptions
- A reduction of off-site trips from 10.5 per month to 7.8 since the new contract.

# Room and Board Revenues Continue to Climb

For the second straight year, the revenues generated from room and board fees, as well as booking fees (recoupment for tax dollars spent on housing sentenced inmates in county jail) increased dramatically. This is a direct result from increased efforts in collecting the owed fees.

# Northwest Shuttle Saves Transportation Money

A new partnership with multiple law enforcement agencies across the entire northwest of the United States now allows for substantial savings in inmate transportation and extradition expenses.

In our first year of fully using this reciprocal cooperating agreement, Black Hawk County has conducted 18 transports at a cost savings of over \$14,000.

# **Inmate Workers Have Impact**

When Sheriff Thompson took office, he promised to increase the impact of the Inmate Worker Program.

Inmates routinely work within the facility mopping floors, cleaning common areas and doing inmate laundry. This effort has now expanded to routine maintenance efforts for snow removal on the sidewalks of the courthouse, jail building and juvenile court services offices, and mowing of these same building's lawns.

Additionally, inmates work in roadside ditches, with county conservation in county parks, and with local city governments in beautification projects throughout Black Hawk County.



# Jail Programming on Overdrive

One of the most marked improvements in recent years for the inmate population has been access to programming.

We offer several different types of programming intended to encourage a change of lifestyle and to deter recidivism in our facility.

Whether faith-based or self-improvement oriented, the jail now offers both court mandated programming as well as self-help offerings.

The list includes: the Batter's Education Program, GED, Narcotics/Alcoholics Anonymous, the Celebrate Recovery Program, Mental Health Education Group, Faith-Based Reentry Program, Bible Study and Church Services.





# Sheriff's Sales Slow as Economy Improves

As is evident by the activity chart below, the Civil Services staff has seen a much needed return to normal levels after 2009 taxed nearly every category of their obligations to the courts.

# Special Services Under New Command

### Sheriff's Website Catches Crooks

Since early in 2009, the Sheriff's Office has used the internet to better inform the public of our services. Starting this year, and with the cooperation of the Waterloo Courier, the website now highlights **Black Hawk County's Most Wanted**.

The list of 10-15 criminals who are currently being sought for criminal charges and warrants for their arrests has been extremely effective.

Through the use of the website and Facebook®, the Sheriff's Office has been able to put approximately 80% of everyone featured on the list in custody.

# Raymond Training Facility Takes Shape

Through the generous offer from Basic Materials Corporation, Black Hawk County was able to lease approximately 37 acres of land for 99 years for \$1.00.

Since the acquisition of the land, slow, methodical development has begun. The first effort was to establish earthen berms to allow for the creation of two firearms training ranges.

By the end of the construction season, a 100 yard and a 50 yard firearms range was nearly finished. Complete with 20 foot high backstops and side-safety berms, the work was completely accomplished with donated equipment, time and expertise.

Our partners include Peterson Contractors Incorporated, Altorfer Incorporated, Murphy Tractor and Equipment, MidCountry Machinery Incorporated, the Black Hawk County Engineer's Office, Black Hawk County Conservation, and many, many others.

Future additions include a classroom and shop building, observation towers, a 300 yard rifle qualification range, and various different scenario buildings on the property.









# Citizen's Advisory Council Launched

Fulfilling a campaign promise and improving a process of ensuring better transparency for the citizens we serve, Sheriff Thompson initiated an effort to develop the Citizen's Advisory Council (CAC).

For nearly a year, a steering committee made up of local interested citizens, representing several organizations, to include: NAACP (National Association for the Advancement of Colored People), Waterloo Human Rights Commission, NAMI (National Alliance for the Mentally III), and CURE (Citizens United for the Rehabilitation of Errants) established operational policies, bylaws and a constitution.

Today, the council serves to provide the citizen's voice, Sheriff's Office advocacy and information flow for improving our operations both inside and outside our jail facility.



# **Budget Concerns Continue**

**Adminstrative Services Division** 

The Sheriff's Office constitutes a large percentage of the overall county budget. Each year, the Sheriff's Office's Administrative staff assesses our asking to ensure that we are able to provide both the court and code mandated services as well as the services that our citizens have come to expect.

It goes without saying that we remain focused on providing the highest quality and level of service without costing the county more money to provide it.

For two years now, the Sheriff's Office has kept a 0% increase in our asking (excluding outside vendor contracts and union employee contract increases).

# Sheriff's Office on Television

Since early in 2010, Sheriff Thompson has been using public access television to better inform and give insight on Sheriff's Office activities through "Sheriff's Spotlight".

The weekly television show, allows the office to highlight important information, statistics and give an inside look at our operations.
