The Sheriff's Office's call volume has continued a slow, downward trend, with the high water mark of 15,328 calls for service in the year











Vehicle Fuel Expense by FY




Most Common Traffic Citations




Jail Food Service Expense by FY

Room and Board Revenue by FY







Harold Oliver Named 2016 Deputy of the Year

Deputy Harold Oliver started his law enforcement career in March of 1994 and has worked in the Jail Division, Patrol Division and now in the Civil Division. He was recognized as the 2016 Deputy of the Year at the



Black Hawk County Law Enforcement Association's annual Christmas party. Harold was recognized for his contagious friendly demeanor, his cheery disposition, and his dedication to duty. Further, he was distinguished because of his quick response to a shots fired incident that played out in front of him while on his way to work in May of this year. Deputy Oliver witnessed the assault and shots being fired, he retrieved his duty belt and pistol from his duffle bag (he was on his way to work) and responded calmly and tactically. He was able to hold the shooter at gunpoint while directing other emergency responders to the scene. His quick actions and calm, clear communication on the radio resulted in the victim of the shooting having aid rendered immediately and the victim lived as a result of his actions.

Deputies Continue to Give Back to the Community in 2016

As with every year, our deputies and staff are very community focused. Through partnerships with other organizations and through our own Black Hawk County Law Enforcement Association, our staff continue to have positive impact outside of their routine duties. Raising funds for special events, other community service organizations, and helping to raise awareness for worthy causes, we are extremely prideful of our staff's commitment and conviction to community service.

Civilian Detention Officers Implemented this Year

In 2016, Sheriff Thompson made the decision to start augmenting the Jail Security staff with Civilian Detention Officers. This is a new position that has not been used since the opening of the new county jail in 1995. The transition is being made through attrition and the jail has already hired 7 Detention Officers so far. The change was made much smoother through several current civilian jail staff members (booking clerks and master control technicians) electing to transfer to the new job classification. The success of this change was further aided through a successful contract negotiation with the staff's union, ratifying the po-

sition and its membership into the collective bargaining unit well before the change occurred.

The civilian positions allow for less training time and quicker acclimation into the job duties. The move has demonstrated immediate benefits both to budget and to staffing levels. Initial plans indicate an effort to replace approximately 50% of the sworn jail staff over the next several years following this attrition plan.



It's All About This Staff

As with most years, the Sheriff's Office's numbers (calls for service, reduced crime rates, case clearance rates, major incident reports, assaults, injuries, and any other indicator of activity/negativity) continue to demonstrate improvement, progress and trending towards the outstanding. This is completely attributable to the excellent staff of the Black Hawk County Sheriff's Office and rather than write long paragraphs outlining those successes, here are photos of these folks in action:

From the Commander:



The Special Services Division of the Black Hawk County Sheriff's Office consists of subdivisions including civil, clerical, training, information technology and records.

The Civil Division continues to consist of five Deputies and a Sergeant whose primary responsibility is to serve legal documents and execute orders for the courts. These legal documents are many different types including subpoenas, wage and bank garnishments, small claims court, lawsuits, divorce papers, evictions, protective orders and many others. During calendar year 2016, Deputies served and executed 12,730 of these documents and court orders.

The Clerical Division consists of nine staff members who administratively support all divisions. They handle the issuance of permits to acquire and carry handguns, the registering of sex offenders, the entering and returning of legal document services, the money that comes in for the jail inmate accounts, among other duties.

The Training Division consists of a Training Coordinator and about 35 certified training instructors on staff. Virtually all staff train at least one day every month, and most of the training occurs at our training facility in Raymond. This facility opened about five years ago and continues to expand as the need presents itself. Regional seminars are held there approximately every quarter year, benefiting many law enforcement agencies and their officers, some from out of state. Fortunately, the facility was built to accommodate large numbers of students for these seminars.

Information Technology is handled by our now full-time and dedicated Network Administrator. This technology is ever-changing and upgrades to many of our systems are on-going.

The Records Division is staffed by two employees who handle all requests for records. With the interpretation of open records laws ever-changing, it is a challenge for them to decide what records we are required to release. The requests for these records has steadily increased over the past few years.



I am looking forward to a very successful new year for the Sheriff's Office, and I thank the citizens of Black Hawk County for supporting our efforts. Please contact me if you have any questions or concerns regarding the Special Services Division.

From the Commander:



The Field Services Division of the Sheriff's Office kept busy during 2016. Law enforcement agencies across the country were under continued scrutiny and several departments were victim to cowardly brutal attacks on members of those departments. Even though acts like this occurred, even here in Iowa the dedicated staff of the Black Hawk County Sheriff's Office was able to shine and continue to be transparent and provide professional law enforcement to the citizens of not only Black Hawk County, but also to the many people that were from out of the area and were in contact with our deputies and other staff members.

The Investigative Division continued to work many cases with arrests being made and property being recovered. Detectives not only worked their own cases, but were able to assist agencies from other jurisdictions.

The SWAT/Negotiations Team were not utilized in 2016, but continued to vigorously train to be prepared for the next time that they are needed.

The Patrol Division was fortunate in 2016 in that only one traffic fatality was recorded in the unincorporated areas of Black Hawk County. That is almost unheard of with the amount of traffic that traverses our county. I believe that patrol presence has helped in this area, while deputies continue to arrest persons for Operating While Intoxicated and Operating While Drugged, and enforce traffic violations on our roadways.

The Water Safety Patrol was called into service on a few occasions. One of which was to assist with a suicidal person that had driven their vehicle into the Cedar River. In another instance, a fisherman failed to have his vehicle in park while placing his boat into a local lake and lost the vehicle, the boat, and the trailer. All were found with special equipment that our patrol boat is equipped with. That unit is operated as a joint venture between Black Hawk County Conservation Rangers and our Field Services Division at the Sheriff's Office.

It is my hope that our goal of no traffic fatalities can be achieved in 2017 and would encourage the motoring public to be aware and to drive defensively. Further, if any citizens need help, they can take comfort knowing that the professional staff of the Black Hawk County Sheriff's Office stands ready to assist them at any-

time, 24 hours a day, 7 days a week, 365 days of the year.

From the Commander:



The Black Hawk County Jail has been located in our current location since 1995, when our office constructed the 272 bed jail. In addition to the 272 beds located in our housing unit, there is capacity for 39 arrestees in the intake area of the jail. These 39 beds are classified as temporary because the arrestee can only remain in this area prior to their initial court appearance, which is held in the jail courtroom every morning of the year.

The jail has been involved in two major changes this past year. First, we recently approved a contract with Stanley Security Systems to install a completely new, state-of-the-art security system and all new locks throughout the facility. Jail staff spent a good portion of this year thoroughly researching and setting the specifications for

this project and Stanley Systems will begin the implementation of this system in the coming months.

Secondly, the jail has also implemented the replacement of Deputy Sheriff positions with civilian Detention Officers. This organizational transformation was implemented to build more staff efficiency at a lower cost to those that pay taxes.

Our jail is currently staffed by 62 Sheriff's Deputies, 7 Detention Officers, 12 Booking Clerks, 12 Master Control Technicians, and 2 Commissary Clerks. Through attrition, we will continue to replace Deputies with Detention Officers in the coming year. Jail employees staff our facility 24/7/365; and make sure those inmates who are ordered here by the Court are kept safely and securely. Their role in preventing escape is vital to the safety of our community and their role is just as vital in preventing the inmates from harming themselves or each other.

During the year, the jail booked 7,074 arrestees into the jail. The average daily population of our jail was 216 for the year.
